#### July 2024 cost-of-living adjustment

A cost-of-living adjustment increases your monthly pension to partially offset inflation. For 2024, the adjustment is 1.2% and will be added to your July payment. This adjustment, and all previous ones, are included in your pension for life.

#### **Cost-of-living adjustment target**

CSSB targets an increase equal to 66.67% of the prior year's Canadian CPI. In 2023, the Canadian CPI was 3.4%. The 2024 1.2% cost-of-living adjustment is only 35.3% of the CPI, marking the third year the target was not met.

## Why cost-of-living adjustments aren't keeping up with inflation

Despite exceeding investment targets, the adjustment account is under pressure for several reasons. These include higher rates of inflation, the funding formula, increased longevity, and changes in the ratio of employees to pensioners.

The superannuation adjustment account funds cost-of-living adjustments. It is separate from the main pension account. In your working years, 10.2% of your contributions went into this account.

Each year, an actuary reviews the adjustment account to determine if an increase can be given based on funds available. The Board then approves or amends this recommendation. As outlined in the *Civil Service Superannuation Act*, cost-of-living adjustments are not guaranteed.
